Pittsburgh Business Group on Health Launches "Benefits Bridge" to Help Small and Mid-Sized Employers Tackle Escalating Healthcare Costs

The escalation cost smaller organizations must grapple with can be crippling to their growth, and in turn, the economic vitality of our region as business owners are forced to choose between healthcare for their workforce or investing in their businesses and communities. It's a true economic hardship business leaders can now address, which is the opportunity Benefits Bridge provides."

Benefits Bridge provides a financial solution by forming a risk pool among employers while delivering efficiency, best practices and the sharing of potential profits achieved through the program. It "bridges the gap" for companies that are currently fully insured, but it allows them to act as and get the benefits of larger, self-insured organizations. Effectively known as a captive insurance model, it aligns similar organizations across different industries, which then share a pooled risk associated with healthcare costs.
